Compliance with Governing Documents. Any Tenant, Occupant or guest of the Lot agrees to abide by the Rules and Regulations and the Bylaws of the Association, and the terms and provisions of the Declaration of Condominium. All provisions of the Declaration of Condominium, the Bylaws, and the Rules and Regulations of the Association shall be applicable and enforceable against every Tenant, Occupant or guest of the Lot to the same extent as against the Owner.

<u>Default.</u> All leases shall be deemed to provide, whether or not such provision is actually set forth in the lease, that the Association is Owner's attorney-in-fact for the purpose of and with the authority to terminate any such lease upon by any Tenant, Occupant, guest or Owner in observing any of the provisions of the Declaration of Condominium, the Bylaws, the Articles of Incorporation and the Rules and Regulations. The Association shall be liable to any Owner, Tenant, Occupant or guest by reason of the Association exercising its right to terminate the lease of a tenant pursuant to this section. This section shall be subject to the ten (10) days' notice requirement as set forth in Article XIII of the Declaration of Condominium.
